DECLARATION OF 26 NOVEMBER 2025 AS PUBLIC HOLIDAY: PUBLIC HOLIDAYS ACT, 1990

Under the powers vested in me by section 1(3) of the Public Holidays Act, 1990 (Act No. 26 of 1990), I declare Wednesday, 26 November 2025 to be a public holiday, which date I have determined in terms of paragraph (c) of Proclamation No. 37 of 26 September 2025, as the polling date for the election of members of local authority councils and regional councils.

**AMENDMENT OF PROCLAMATION NO. 37 of 26 SEPTEMBER 2025:
ELECTORAL ACT, 2014**

Under the powers vested in me by section 64(1)(c) of the Electoral Act, 2014 (Act No. 5 of 2014), read with section 65, I amend Proclamation No. 37 of 26 September 2025 –

- (a) in Schedule A –
